#### **General Notes**

- 1 The candidate and nominators must be local authority electors of the Rotorua Energy Charitable Trust district.
- 2 A nominator may be a residential or ratepayer elector.
- 3 A candidate may not nominate themself for office.
- 4 Under section 121 of the Local Electoral Act 2001, any person is liable on summary conviction to a fine of \$2,000 who:
  - a) consents to being nominated as a candidate when knowing themselves to be ineligible for election (see below); or
  - b) nominates any person as a candidate whom they know to be ineligible for election; or
  - c) not being the candidate, signs any nomination paper knowing that they are not qualified to vote at the election.
- 5 A candidate may, under section 56 of the Local Electoral Act 2001, be nominated under a name which the candidate is commonly known, provided that the name will not:
  - cause offence to a reasonable person;
  - be unreasonably long;
  - be or resemble an official title or rank;
  - cause confusion or mislead electors.
- 6 The name appearing on the voting document will not include initials or titles such as JP or Dr. These can be included in the candidate profile statement if desired.
- 7 A candidate profile statement, including a recent passport-size photograph, will be included with the voting documents for dispatch to electors. For further information about candidate profile statements, please see additional information provided with this nomination paper.
- 8 Each nomination must be accompanied by the required deposit of \$200 (inclusive of GST). This is refunded if certain criteria apply. Payment of the nomination deposit can be made by cash, internet transfer, bank cheque or personal cheque (made payable to Independent Election Services Ltd).
- 9 Nominations of candidates must be in the hands of the electoral officer or an electoral official not later than noon on Friday 27 September 2019.
- 10 Nominations can be returned by post to the electoral office or hand-delivered to the Rotorua Energy Charitable Trust (1358 Eruera Street, Rotorua).

## Candidate Restrictions (Deed of Trust, Rule 2.1)

# The following persons shall not be eligible for appointment as a Trustee and may not hold office as a Trustee:

- A bankrupt who has not obtained a final order of discharge or whose order of discharge has been suspended for a term not yet expired, or is subject to a condition not yet fulfilled, or to any order under section 111 of the Insolvency Act 1967;
- b) A person who has been convicted of any offence punishable by a term of imprisonment of two or more years, unless that person has obtained a pardon or has served the sentence or otherwise suffered the sentence imposed upon that person;
- c) A person who has been sentenced to imprisonment for any offence unless that person has obtained a pardon or has served the sentence;
- d) A person to whom an order made under section 135 of the Companies Act 1993 applies;
- e) A person who is mentally disordered within the meaning of the Mental Health (Compulsory Assessment & Treatment) Act 1992;
- A person who is subject to a property order made under section 30 or section 31 of the Protection of Personal and Property Rights Act 1989.

# GENERAL

The Rotorua Energy Charitable Trust is one of the largest charitable trusts in New Zealand. Established in 1994, the Trust's kaupapa (vision) is to help ensure 'A better Rotorua for all'.

Accordingly, trustees look to balance the needs of today, while maintaining a financial legacy for the future.

# **2019 ELECTION**

Every three years, eligible voters in the Rotorua Energy Charitable Trust district elect six trustees to the Trust. This will take place by postal and online vote between **Friday 1 November and Saturday 23 November 2019**.

# NOMINATIONS

Nominations will open on Friday 30 August 2019 and close at noon on Friday 27 September 2019.

- i. Candidates must be electors of the Rotorua Energy Charitable Trust district and cannot (under Rule 2.1 of the Deed of Trust) be:
- ii. a bankrupt (who has not obtained a final order of discharge);
- iii. a person convicted of any offence punishable by a term of imprisonment of 2 years or more;
- iv. a person sentenced to imprisonment for any offence unless pardoned or served the sentence;
- v. a person who has an order under section 135 of the Companies Act 1993;
- vi. a person mentally disordered within the meaning of the Mental Health (Compulsory Assessment and Treatment) Act 1992;
- vii. a person subject to a property order under section 30 or 31 of the Protection of Personal and Property Rights Act 1989.

Electors may post their completed voting documents back to the Electoral Officer using the pre-paid envelope supplied with the voting document, or vote online. Completed voting documents may also be hand delivered to a ballot box at the offices of the Rotorua Energy Charitable Trust, 1358 Eruera Street, Rotorua. To be counted, all completed voting documents must be received by the Electoral Officer by post, online or hand, by 12 noon, Saturday 23 November 2019.
